To participate, you will need an activated "**Dental Benefit Card**", which you must present at the time of service. To enroll and receive your activated card, scan this code, or go to **www.dentalbenefitprogram.com** and follow these instructions:



Step 1) Click on the "Get Started No Cost" button. Then, select the "I have received a Group ID# only and....." option.

Step 2) Using the Group ID # (**GACC100**) located on the front of your sample card below; enter your registration information in the appropriate fields.

Step 3) Once activated, you will be assigned a **Patient ID#** that you should write down on the sample card below, in the space provided. Your permanent card will be mailed to you in 3-5 working days.

Step 4) Should you need to see a dentist immediately, you can use this letter with your Group and Patient ID #s at the dental office you select. Log into the site and view the participating dentists and discounted fee schedule at any time, by entering your Group ID# and Patient ID#.

Your dental benefit card can only be used at participating Dental Benefit Program dental practices. Payment arrangements must be made with the dentist at the time of service. The Dental Benefit Program is more cost effective than other dental benefit options, eliminating the limitations associated with dental insurance such as: deductibles, co-pays, exclusions, waiting periods and annual maximums.

Along with this valuable benefit, the **Dental Benefit Program** provides **free** (no set up fee or annual charges) **health savings accounts** to qualified and activated patients through the Bank of the Cascades. Health savings accounts are an easy way to budget and pay for dental work, rollover each year, and provide tax benefits for qualified patients.
